* ALL deposits to "reserve" a puppy are non-refundable.

We care about the health and well being of each puppy. We have a veterinary examination on all puppies (except those that will be notified in writing). This exam happens between 7-9 weeks of age. It is a detailed full examination at no additional charge to the purchaser. If your puppy comes with a written examination, you are then agreeing to accept the results of this exam as accurate, and you do not need to take your puppy for another initial vet exam. The "BUYER" accepts our veterinary report as a true statement of health to the "BUYER'S" said puppy.

Vaccination Records and Health Exam - will be provided at the time of delivery of puppy to "BUYER". "SELLER" (MnJ Parti Poodles) will not pay for any vet bills incurred from any vet exam made by the "BUYER".

Puppies are started on a worming program at two weeks. We wean the pups around four to five weeks depending on their general health condition. We have your pup on nutritious solid dry puppy food and will inform you which brand we are using and urge you to continue with it or mix the brand that you prefer with the one we are using for at least five or six days to minimize digestive problems.

In the event "BUYER" must return the puppy to MnJ Parti Poodles, the following conditions must be fulfilled:

- 1) Puppy must be returned in good health and with all paperwork to our physical address in Kaufman, Texas.
- 2) WE must approve in writing the day and time of the puppy's arrival.
- 3) No refund will be given
- 4) MnJ Parti Poodles or agents will not pay any expenses related to the return of the puppy
- 5) Veterinary letter must be sent in writing prior to the puppy's return stating what life threatening defect is in the said puppy.

AKC Registration is for Standard Poodles only. The Standard Poodle you are purchasing can be registered with AKC (American Kennel Club). What the American Kennel Club Registration means is that AKC maintains information regarding the parentage and identity of the puppy. It does not guarantee the quality of health of this puppy, and it does not guarantee quality lineage. Since dog pedigree registries depend in large part on the honesty and accuracy of persons registering dogs, registration does not guarantee the accuracy of the lineage.

*Upon written request, within 30 days of the sale, the "BUYER" may request AKC registration papers, any request made after the 30 day period will not be granted.

We are NOT liable for any genetic testing or DNA results.

The Terms of our Hip Guarantee is as follows:

For a Hip claim: the dog must have had their hips x-rayed by the age of 26 months to be covered by this Guarantee. All X-rays must be submitted to the OFA (Orthopedic Foundation for Animals) for evaluation by veterinary radiologists. Preliminary evaluation after 12 months of age is acceptable. Proof of genetic dysplasia from the OFA as well as proof of the animal being spayed or neutered must be presented to MnJ Parti Poodles. BUYER accepts responsibility for not overfeeding the dog nor allowing strenuous exercise before closure of growth plates (which can bring about hip dysplasia). OFA rating must be "poor".

You puppy is also covered by a 26 month genetic guarantee that guarantees your puppy is free of any life threatening genetic conditions. ANY claim of an inheritable genetic condition that is life threatening must be present to MnJ Parti Poodles from a licensed Veterinary Specialist stating the condition is inheritable and could not in any way be caused by injury or illness. We must also receive proof of spay or neuter and all evidence must be presented to MnJ Parti Poodles.

BUYER accepts responsibility to not jog with puppy on hard surfaces or allow puppy to jump from heights (i.e. from car, pick up or sofa) before 18 months of age. As DJD Grade 1 type elbow dysplasia or unilateral elbow dysplasia can be the result of poor nutrition, improper exercise, injury from jumping or rough playing, no warrantee shall apply for this condition.

—This Guarantee is not transferrable. To make a claim against this Guarantee, the original owner who bought this dog must still own this dog.
